Dispute resolution is what the world needs, don't you think? From international squabbles to the neighbor next door, the world needs to benefit from our practice of Transformative Mediation.

Parties come to the mediation table. Their voices are heard; their choices are honored; and remarkably such a simple formula yields results. As a mediator myself I can attest to it. Nothing is so surprising to a mediator to learn that parties felt supported and that they were able to speak to each other in a way that had not been possible. Surprising? Probably not. It is what we do at CDRC.

And, we are going to be doing something new this year. When only one party agrees to mediate we are offering one-on-one coaching so that one party can better handle the conflict. We are even going to offer it to businesses so that employees can have conflict resolution skills in their daily environment. This expands our outreach to our three county communities: Chemung, Tompkins, and Schuyler.

Mediation and Coaching are what we are doing in 2019. Our corps of volunteer mediators means that mediations are affordable at no cost to parties. When staff are involved we charge an extremely modest fee for their time. How can we do this?

We can do this because people like you support us. You know that the world will be a better place if parties (strong and weak, important and not-so-important) would listen to and honor one another. CDRC is part of that effort to make the world a better place – at least our little part of it.

# Conflict Coaching

Conflict often announces itself as a threatened identity, a bad feeling, or a loss of power. Conflict really comes down to three big questions, who I want to be respected as, how do I want to

feel in this situation, and what can I make happen in this situation.

A recent client struggling with a co-worker situation stated, "I wasn't sure what to expect from the process of coaching, however, I am so thankful I made the decision to use your conflict coaching services. Throughout my sessions I was able to gain clear insights into how I was approaching my conflict situation, and discovered what was important to me and why. Once I had a better perspective of my situation it was much easier to decide on the next steps that I wanted to take. Conflict coaching gave me the confidence and clarity to move forward without being overwhelmed by the fear and confusion I had been feeling previously."

Our conflict coaches help people think through these questions, so that a party can see clearly what future situation is best for them. With the support of a conflict coach, a party can see the possibilities in how they manage their conflict and have a better sense of the different positive possibilities that are available to move forward.
